# FICE INTERNATIONAL ACTIVITIES FOR 2013

During the year 2013 FICE International activities could be summarized in the following topics:

- 1. National Sections Activities.
- 2. FICE International standpoints and positions on different topics, related to children and their welfare.
- 3. Organizing and co-organizing conferences and congresses.
- 4. International relations.
- **5.** Organizational development and membership.
- **6.** Forthcoming events.

# **1.** *National Sections Activities - See the country reports*

FICE International unites more than 30 countries worldwide. Each national section has a specific operational structure, type of operation and financing (volunteers, professional advisers or staff members, number of members or activities in the country), but the basic philosophy and principles are the same as those of FICE International. Due to this specific situation, the country reports are very important instrument for coordination, planning and networking in FICE International. The main activities and actions are implemented on a country level.

In the country reports are presented results of the work of the national section of each country. The most common results are: charity projects for children and families at risk, activities with children living outside the family, exchange of knowledge and experience between professionals, organizing and participating in conferences and congresses on social issues, expressing a position on important global topics to improve children's lives, international cooperation.

# 2. FICE International standpoints and positions on different topics, related to children and their welfare

FICE International continued observing the situation in Syria and particularly the childrenimmigrants' issue. Different FICE National sections had alarmed the public society about the children's rights.

Another discussion, on which FICE International took a standpoint, was the topic, related to the appeals of former clients "Standing up for the rights of former clients of residential care – towards a modern, participatory model for foster and residential care". The Declaration on former clients ends with: "Recalling the dramatic experience of former clients of residential care in the 50s, 60s, and 70s, today's residential care and other forms of care must see it as their duty to implement these findings".

FICE International representatives took part in discussions and consultations on:

- The "Moving Forward Implementing the Guidelines for the Alternative Care of Children" handbook;
- "Formal care settings characteristics" paper;
- "What happens after out-of-home care? Models of good practice for care leavers in Germany" international expert workshop.





FICE International supported UNICEF's appeal for non-placing children up to 3 years in an out of family care.

# 3. Organizing and co-organizing conferences and congresses.

FICE Europe, as a part of FICE International, collaborated in the organization of the following congresses:

- AIEJI's 18th World Congress took place in Luxembourg, 2 5 April 2013 and was hosted by APEG Association professionelle des éducateurs gradués, the national association of social educators in Luxembourg. The main theme of the congress was: Integration and Social Inclusion. Website: http://www.worldcongress.lu/index.php?lang=en.
- 3-rd ENSACT Joint European Conference, 16-19 April 2013, Istanbul, Turkey. Main theme was: Social Action in Europe: Towards Inclusive Policy and Practice. ENSACT's organizational partners are: European Association of Schools of Social Work (EASSW), Formation d'Educateurs Sociaux Européens / European Social Educator Training (FESET), Fédération Internationale des Communautés Educatives (FICE), International Association of Social Educators (AIEJI), International Council on Social Welfare European Region (ICSW), International Federation of Social Workers European Region (IFSW). Website: http://aieji.net/world-congress/.
- In June 2013, in St. John's, Newfoundland and Labrador, Canada was held the first ever Child and Youth Care World Conference, Connecting at the Crossroads. This World CYC conference was hosted by the Child and Youth Care Association of Newfoundland and Labrador in collaboration with the International Child and Youth Care Network (CYC-Net) and FICE-International.

By those partnership events, directed towards knowledge and skills exchange for working with people in a straitened circumstances, FICE International fulfills its main function: to support the children and the families, through more purposeful and effective professionals' work, thanks to good practice implementation, presented by different countries.

FICE International realized four years project dedicated to Inclusion. The project was focused on the discussion of the aims and concepts of inclusion and the challenges these pose for experts and for society. During these four years actual practical models claiming to have achieved the goals of inclusion was exchanged and discussed in FICE International countries, especially those related to education, culture, and economy.

FICE International and FICE Switzerland with the partnership and support of "Kantonale BEObachtungsstation", "Stiftung Schulungs- und Wohnheime Rossfeld", "Saurer Partner GmbH", "Kinderheim St. Benedikt", "Institut für Kinder- und Jugendhilfe GmbH", volunteers as well as the Bern Canton had been working hard and very systematically on organizing the Congress in 2013 (www.fice-congress2013.ch), 8-12 October, in Bern, Switzerland, as part of Project "Inclusion". The focus of the Congress was the discussion of the goals and concepts of Inclusion and the challenges from both professional and social points of view, and was aiming at people engaged in extra familial care of children and youths and in the enforcement of their rights, i.e. professionals with practical experience, educators and researchers as well as all interested persons involved in education, culture, politics, and business. Right before the beginning of the Congress, FICE International held its Federal Council and General Assembly. Regular elections were carried out and the President of FICE Inter Dashenka Kraleva (Bulgaria), the Secretary General Bettina Terp (Austria), and the Treasurer Rolf Widmer (Switzerland) were reelected and were given mandate for the next three years. At the opening ceremony of the FICE World Congress at the National Hotel Bern delegations from six continents came together: Armenia,





Australia, Austria, Bosnia and Herzegovina, Brazil, Bulgaria, Cameroon, Canada, China, Colombia, Ethiopia, Finland, Germany, India, Ireland, Israel, Japan, Kenya, Luxembourg, Nederland, Palestine, Romania, Senegal, Serbia, South-Africa, Spain, United Kingdom, Ukraine, USA and Switzerland. The presentation of each country was led by two young people with disabilities. Following the tradition of FICE congresses the experiences and ideas of youths played an important role. The project International Youth-Practice-Exchange also was presented. It enables encounters and the exchange of experiences among children, youths and persons involved in projects or from institutions working with concepts of participation and inclusion. The exchange took place on a virtual platform over a longer period as well as in a two-week camp before and during the Congress. The 32-nd FICE International Congress was a very special event for one more reason. In an additional ceremony the CRISTALS, representing the Good Practices, were introduced. They will continue to be presented to the FICE professional community and to contribute to the inclusion of the groups in risk. During the closing ceremony of the FICE Congress a Panel discussion on the subject of Inclusion took place. In that final discussion 6 organizations were presented: Maria Herczog - Eurochild's President, Christian Hosmann - SOS Kinderdorf's Director in Switzerland, Bettina Terp - FICE International Secretary General, Heather Modlin - CYC-Net Board of Governors, Colin Chatten - IFCO's Treasurer and Matilde Luna - Relaf's Project Leader.

After the Congress in October the next Congress of the international organization will be held in Vienna in 2016, with FICE Austria, FICE International and the International Child and Youth Care Network CYC-Net, as main organizers under the patronage of the Government of Vienna.

#### 4. International relations.

FICE International management in the person of its president, secretary general and vice presidents collaborated on specific children topics with the following organizations:

- Eurochild;
- The International Foster Care Organization (IFCO);
- International Association of Social Educators (AIEJI);
- The International Child and Youth Care Network (CYC-Net);
- ENSACT;
- RELAF (Latin American Foster Care Network, for the Right to community and family-based care for children and adolescents)
- Fundació Acció Social Infància (FASI).

A progress has been achieved in supporting FICE Latin America development, after signing an agreement between FICE International and RELAF for FICE representation on that continent through their organization.

A step towards building up bridges with Latin America was also - a Brazilian organization candidacy for FICE International membership. There are opening steps in that direction with Australian representatives.

# 5. Organizational development and membership.

During 2013 FICE International continued its organizational consolidation. The contact with the members has been improved through correspondence on different topics, in relation with mutual projects, devoted to the children between the different National sections, visits for experience and topics exchange connected with children policies.





For far more improved functioning and networking was taken a decision for a Technical Assistance appointment, which would make the mutual work and network communication more effective. As a result on FICE International website was published information about the FICE International experts from different countries. They are members of FICE International who are working in different child care fields. In addition FICE International started its own Open Group in Facebook, where interesting materials, information about future events could be found, old or new friends can be met and members have the possibility to share their opinion or to discuss important for them issues with other professionals in the childcare field.

A connection with Brazil, Sweden and Australia has been made, which gave a possibility for information and practice opportunities. The Partnership with Latin American Network RELAF was strengthened and the plan for work together was developed.

FICE International management made steps towards partnership resumption with UNESCO. During 2013 a project between FICE Kenya and FICE Austria was presented. It was directed towards training of social workers from Kenya, working with children at risk. FICE International is also correctly listed as an organization in Roster status with ECOSOC.

# 6. Forthcoming events.

- FICE International is to prepare and adopt new Strategic Plan 2014-2020 and the Action plan to it for 2014-2016.
- FICE International will hold its next international Congress in Vienna, Austria, in the last week of August, 2016. Since FICE was founded in 1948, 32 FICE Congresses throughout the world have brought together front-line experts in providing care and support for children without and outside the family. FICE Congresses are aimed at people involved in out-of family care for children and youths and the enforcement of children's rights; these include professionals in practice, research, teaching, as well as interested attendants from the fields of education, culture, politics, and business.
